Papers were solicited either as long (15 page), or short (8 page) submissions. Short-paper submissions were refereed to exactly the same high standards as long-paper submissions but naturally were expected to contain a smaller quantity of new material. Thus there is no disti-tion in these proceedings between short and long papers. I used the excellent EasyChair conference management system to support this process of reviewing, and for the collation and organization of these proceedings.
