Organized to support an "early transcendentals" approach to the multivariable section of the course, this version of Rogawski's highly anticipated text presents calculus with solid mathematical precision but with an everyday sensibility that puts the main concepts in clear terms. It is rigorous without being inaccessible and clear without being too informal--it has the perfect balance for instructors and their students.

Based on many years of experience of the author Complex Analysis with Vector Calculus provides clear and condensed treatment of the subject. It is primarily intended to be used by undergraduate students of engineering and science as a part of a course in engineering mathematics, where they are introduced to complex variable theory, through conceptual development of analysis. The book also introduces vector algebra, step by step, with due emphasis on various operations on vector field and scalar fields. Especially, it introduces proof of vector identities by use of a new approach and includes many examples to clarify the ideas and familiarize students with various techniques of problem solving. An authorised reissue of the long out of print classic textbook, Advanced Calculus by the late Dr Lynn Loomis and Dr Shlomo Sternberg both of Harvard University has been a revered but hard to find textbook for the advanced calculus course for decades. This book is based on an honors course in advanced calculus that the authors gave in the 1960's. The foundational material, presented in the unstarred sections of Chapters 1 through 11, was normally covered, but different applications of this basic material were stressed from year to year, and the book therefore contains more material than was covered in any one year. It can accordingly be used (with omissions) as a text for a year's course in advanced calculus, or as a text for a three-semester introduction to analysis. The prerequisites are a good grounding in the calculus of one variable from a mathematically rigorous point of view, together with some acquaintance with linear algebra. The reader should be familiar with limit and continuity type arguments and have a certain amount of mathematical sophistication. As possible introductory texts, we mention Differential and Integral Calculus by R Courant, Calculus by T Apostol, Calculus by M Spivak, and Pure Mathematics by G Hardy. The reader should also have some experience with partial derivatives. In overall plan the book divides roughly into a first half which develops the calculus (principally the differential calculus) in the setting of normed vector spaces, and a second half which deals with the calculus of differentiable manifolds.

Vector calculus is the fundamental language of mathematical physics. It provides a way to describe physical quantities in three-dimensional space and the way in which these quantities vary. Many topics in the physical sciences can be analysed mathematically using the techniques of vector calculus. These topics include fluid dynamics, solid mechanics and electromagnetism, all of which involve a description of vector and scalar quantities in three dimensions. This book assumes no previous knowledge of vectors. However, it is assumed that the reader has a knowledge of basic calculus, including differentiation, integration and partial differentiation. Some knowledge of linear algebra is also required, particularly the concepts of matrices and determinants. The book is designed to be self-contained, so that it is suitable for a programme of individual study. Each of the eight chapters introduces a new topic, and to facilitate understanding of the material, frequent reference is made to physical applications. The physical nature of the subject is clarified with over sixty diagrams, which provide an important aid to the comprehension of the new concepts. Following the introduction of each new topic, worked examples are provided. It is essential that these are studied carefully, so that a full understanding is developed before moving ahead. Like much of mathematics, each section of the book is built on the foundations laid in the earlier sections and chapters.
