Alphabetical entries cover individual historians; surveys of national or regional historiographies; and topical articles on themes, -isms, and periods. More than a generation of German-speaking students around the world have worked their way to an understanding and appreciation of the power and beauty of modern theoretical physics - with mathematics, the most fundamental of sciences - using Walter Greiner's textbooks as their guide. The idea of developing a coherent, complete presentation of an entire field of science in a series of closely related textbooks is not a new one. Many older physicists remember with real pleasure their sense of adventure and discovery as they worked their ways through the classic series by Sommerfeld, by Planck and by Landau and Lifshitz. From the students' viewpoint, there are a great many obvious advantages to be gained through use of consistent notation, logical ordering of topics and coherence of presentation; beyond this, the complete coverage of the science provides a unique opportunity for the author to convey his personal enthusiasm and love for his subject. The present five volume set, *Theoretical Physics*, is in fact only that part of the complete set of textbooks developed by Greiner and his students that presents the quantum theory. I have long urged him to make the remaining volumes on classical mechanics and dynamics, on electromagnetism, on nuclear and particle physics, and on special topics available to an English-speaking audience as well, and we can hope for these companion volumes covering all of theoretical physics some time in the future.

"The fox knows many things, but the hedgehog knows one big thing." This ancient Greek aphorism, preserved in a fragment from the poet Archilochus, describes the central thesis of Isaiah Berlin's masterly essay on Leo Tolstoy and the philosophy of history, the subject of the epilogue to *War and Peace*. Although there have been many interpretations of the adage, Berlin uses it to mark a fundamental distinction between human beings who are fascinated by the infinite variety of things and those who relate everything to a central, all-embracing system. Applied to Tolstoy, the saying illuminates a paradox that helps explain his philosophy of history: Tolstoy was a fox, but believed in being a hedgehog. One of Berlin's most celebrated works, this extraordinary essay offers profound insights about Tolstoy, historical understanding, and human psychology. This new edition features a revised text that supplants all previous versions, English translations of the many passages in foreign languages, a new foreword in which Berlin biographer Michael Ignatieff explains the enduring appeal of Berlin's essay, and a new appendix that provides rich context, including excerpts from reviews and Berlin's letters, as well as a startling new interpretation of Archilochus's epigram.

Letter writing was widespread in the Graeco-Roman world, as indicated by the large number of surviving letters and their extensive coverage of all social categories. Despite a large amount of work that has been done on the topic of ancient epistolography, material and formatting conventions have remained underexplored, mainly due to the difficulty of accessing images of letters in the past. Thanks to the increasing availability of digital images and the appearance of more detailed and sophisticated editions, we are now in a position to study such aspects. This book examines the development of letter writing conventions from the archaic to Roman times, and is based on a wide corpus of letters that survive on their original material substrates. The bulk of the material is from Egypt, but the study takes account of comparative evidence from other regions of the Graeco-Roman

world. Through analysis of developments in the use of letters, variations in formatting conventions, layout and authentication patterns according to the sociocultural background and communicational needs of writers, this book sheds light on changing trends in epistolary practice in Graeco-Roman society over a period of roughly eight hundred years. This book will appeal to scholars of Epistolography, Papyrology, Palaeography, Classics, Cultural History of the Graeco-Roman World.
