

Aca Ethical Standards Casebook Seventh Edition

The Cambridge Handbook of Applied Psychological Ethics is a valuable resource for psychologists and graduate students hoping to further develop their ethical decision making beyond more introductory ethics texts. The book offers real-world ethical vignettes and considerations. Chapters cover a wide range of practice settings, populations, and topics, and are written by scholars in these settings. Chapters focus on the application of ethics to the ethical dilemmas in which mental health and other psychology professionals sometimes find themselves. Each chapter introduces a setting and gives readers a brief understanding of some of the potential ethical issues at hand, before delving deeper into the multiple ethical issues that must be addressed and the ethical principles and standards involved. No other book on the market captures the breadth of ethical issues found in daily practice and focuses entirely on applied ethics in psychology.

In *Foundations of Ethical Practice, Research, and Teaching in Psychology and Counseling*, Kitchener and Anderson lay a conceptual foundation for thinking well about ethical problems. Whereas the first edition focused mainly on ethical reasoning and decision making, this new edition draws more explicitly on all components of James Rest's model of moral/ethical behavior, including moral/ethical sensitivity, moral/ethical decision making, moral/ethical motivation, and the ego strength to follow through on the

decision. The book addresses five key principles of ethical decision making and includes updated sections on research, teaching and supervision, and practice. It discusses the relationship of the ethical principles and the model of ethical decision-making to professional ethical codes, while offering discussion questions, case scenarios, and activities to help the reader focus on ethical character and virtue. *Foundations of Ethical Practice, Research, and Teaching in Psychology and Counseling* gives psychologists, students, and trainees the tools they need to analyze their own ethical quandaries and take the right action.

The real world of professional ethics in art therapy is, more times than not, a spectrum of shades of gray. In this exceptional new fourth edition, the authors raise questions and provide information related to the many ethical dilemmas art therapists face. Several chapters refer to the Ethical Principles for Art Therapists and Code of Professional Practice of the Art Therapy Credentials Board. Changes that were made to the AATA Ethics Document in 2013 are discussed. Models of how to think through and resolve the difficult ethical problems art therapists encounter during their professional lives are presented. The importance of multicultural approaches is expanded with the discussion that competence is a baseline for practice as an art therapist. Significant updates were made to the chapter that explores art therapy in the digital age. The appendices contain ethics documents of the British Association of Art Therapists for comparison. Issues involving dual relationships in counseling are discussed in this monograph. Dual relationships occur when counselors have another, significantly different, relationship with one of their clients, students, or supervisees. This monograph is intended to be a resource that reflects the current thinking of the counseling profession and that represents the diversity of opinion that exists. The book is organized in four parts: Part I contains two chapters that provide a general introduction and overview of dual relationships. In chapter 1 the issues and areas of concern are defined. In chapter 2 the focus is on sexual dual relationships. The considerable body of existing literature is reviewed and discussed and questions are raised about some "gray areas." The remainder of the monograph focuses primarily on non-sexual dual relationships. In part II (containing chapters 3, 4, and 5) issues in the preparation and

supervision of counselor trainees are examined. Part III (containing chapters 6-11) focuses on how dual relationships affect practitioners in various settings and aspects of their work. Issues that confront counselors in private practice, college personnel workers, school counselors, rehabilitation counselors, group counselors, and consultants are discussed. In the single chapter of part IV (chapter 12) key themes are identified, questions are asked to encourage integration and reflection, and a decision-making model is presented. It is noted that dual relationships, especially nonsexual dual relationships, will in all probability continue to be discussed and debated well into the 1990s. (ABL)

This fourth edition of the Ethical Standards Casebook was developed for use in a class in ethics in counseling or in other settings where ethical issues are considered. Section 1 presents the revised American Association for Counseling and Development (AACD) "Ethical Standards" adopted by the Governing Council in March 1988. Section 2 presents each individual ethical standard followed by several incidents intended to illustrate and clarify the meaning of the standard. The incidents vary in their seriousness, ranging from gross unethical conduct to behavior reflecting poor practice or questionable judgment. Section 3 provides a series of case studies that are more detailed and complex than the incidents in the previous section and are more typical of the situations an AACD member may encounter. The case

studies reflect the types of complaints that the Ethics Committee receives as well as the current and emerging concerns of the membership. Section 4 presents a series of essays intended to provide further information and provoke thought about ethical issues of particular concern to counselors. The appendices contain information to which the AACD member may need to refer from time to time, including: divisional codes of ethics; the ethical standards of the National Board for Certified Counselors; the AACD Policies and Procedures for Processing Complaints of Ethical Violations; and a description of the purpose and procedure of the AACD Legal Action Program.
