Munsterberg's *On the Witness Stand*, published in 1908. These early roots can mislead the casual observer about the history of psychology and law. Vigorous and sustained research in the field is a recent phenomenon. It is only 15 years since the first review of psychology and law appeared in the *Annual Review of Psychology* (Tapp, 1976). The following year saw the first issue of *Law and Human Behavior*, the official publication of the American Psychology-Law Society and now the journal of the American Psychological Association's Division of Psychology and Law. Few psychology departments offered even a single course in psychology and law before 1973, while by 1982 1/4 of psychology graduate programs had at least one course, and a number had begun to offer forensic minors and/or joint J. D. / Ph. D. programs (Freeman & Roesch, see Chapter 28). Yet this short period of less than 20 years has seen a dramatic level of activity.
