This excellent new work confronts two important oral health policy concerns in the United States: the disparities in the oral disease burden and the inability of certain segments of the population to access oral health care. The book examines in depth this crucial yet frequently overlooked indicator of seniors' quality of life. Diagnostic errors are important in all branches of medicine because they are an indication of poor patient care. As the number of malpractice cases continues to grow, radiologists will become increasingly involved in litigation. The aetiology of radiological error is multi-factorial. This book focuses on (1) some medico-legal aspects inherent to radiology (radiation exposure related to imaging procedures and malpractice issues related to contrast media administration are discussed in detail) and on (2) the spectrum of diagnostic errors in radiology.

Communication issues between the radiologists and physicians and between the radiologists and patients are also presented. Every radiologist should understand the sources of error in diagnostic radiology as well as the elements of negligence that form the basis of malpractice litigation.

Tinnitus and oversensitivity to sound are common and hitherto incurable, distressing conditions that affect a substantial number of the population. Pawel Jastreboff's discovery of the mechanisms by which tinnitus and decreased sound tolerance occur has led to a new and effective treatment called Tinnitus Retraining Therapy (TRT). This book presents a definitive description and justification for the Jastreboff neurophysiological model of tinnitus, outlining the essentials of TRT, reviewing the research literature justifying their claims, and providing an expert critique of other therapeutic practices.

It covers the process of diagnosis, investigation, management, and counselling for patients. Most of the topics fit onto a double-page spread ensuring that the book is an accessible, quick reference for the clinic or hospital consultation. Where available, diagnostic criteria for specific conditions are included as well as contact details for support groups. The book is well illustrated and has an up-to-date bibliography and glossaries of terms used in genetics and dysmorphology. The authors have used their experience to devise a practical clinical approach to many common genetic referrals, both out patient and ward based. The most common Mendelian disorders, chromosomal disorders, congenital anomalies and syndromes are all covered. In addition there are chapters on familial cancer and pregnancy-related topics such as foetal anomalies, teratogens, prenatal and pre-implantation diagnosis. The book also provides information on the less common situations, where management is particularly complex, or important genetic concepts are illustrated.

Despite an ever increasing array of antimicrobial agents and an expanding vaccination program, infectious diseases remain an important cause of morbidity and mortality in children. This issue will address some of the most important contemporary issues in pediatric infectious diseases, with emphasis on clinical presentation, prevention, and therapy. General chapters on immunization and chemotherapy (antiviral, antibiotic, antiparasitic, and antifungal) will be complemented by discussion of common clinical syndromes, including otitis media, pharyngitis, bronchiolitis and pneumonia, gastroenteritis, bone and joint infections, meningitis, and periodic fevers.

Leptospirosis is a potentially serious but treatable zoonotic disease representing a worldwide public health hazard. Its symptoms may mimic those of a number of other unrelated infections such as influenza meningitis hepatitis dengue or viral haemorrhagic fevers. It is important to distinguish leptospirosis from these diseases. For this reason new diagnostic methods have been developed in recent years. In humid tropical and subtropical areas where most developing countries are located leptospirosis poses a greater health problem than in areas with a temperate climate. Because leptospirosis is easily overlooked and consequently underreported in many parts of the world it is necessary to increase awareness and knowledge of the disease as a public health threat. The aim of these guidelines is to assist in this process. The target groups to which these guidelines are directed consist of health workers clinicians laboratory technicians microbiologists public health workers veterinarians and biologists with an interest in zoonoses having no specialized knowledge of leptospirosis but who wish to be generally informed about the microorganism concerned and the disease that it may cause. This is not a handbook and avoids technical details but the interested reader can find further information in the annexes and the general bibliography. These guidelines are concerned essentially with human leptospirosis.
