In a story of reform and backlash, Lorraine McDonnell reveals the power and the dangers of policies based on appeals to voters' values. Exploring the political struggles inspired by mass educational tests, she analyzes the design and implementation of statewide testing in California, Kentucky, and North Carolina in the 1990s. Educational reformers and political elites sought to use test results to influence teachers, students, and the public by appealing to their values about what schools should teach and offering apparently objective evidence about whether the schools were succeeding. But mass testing mobilized parents who opposed and mistrusted the use of tests, and left educators trying to mediate between angry citizens and policies the educators may not have fully supported. In the end, some testing programs were significantly altered. Yet despite the risks inherent in relying on values to change what students are taught, these tests and the educational ideologies behind them have modified classroom practice. McDonnell draws lessons from these stories for the federal No Child Left Behind act, with its sweeping directives for high-stakes testing. To read this book is to witness the unfolding drama of America's educational culture wars, and to see hope for their resolution.

This unique handbook offers an analytical review of the education systems of all European countries, following common analytical guidelines, and highlighting the paradox that education simultaneously pursues a universal value as well as a national character. Comparing this view of the invisible hand with the vision described by Kafka--in which individuals pursuing their atomistic interests, devoid of moral compunction, end up creating a world that is mean and miserable--Basu argues for collective action and the need to shift our focus from the efficient society to one that is also fair. Using analytic tools from mainstream economics, the book challenges some of the precepts and propositions of mainstream economics. It maintains that, by ignoring the role of culture and custom, traditional economics promotes the view that the current system is the only viable one, thereby serving the interests of those who do well by this system. *Beyond the Invisible Hand* challenges readers to fundamentally rethink the assumptions underlying modern economic thought and proves that a more equitable society is both possible and sustainable, and hence worth striving for. By scrutinizing Adam Smith's theory, this impassioned critique of

contemporary mainstream economics debunks traditional beliefs regarding best economic practices, self-interest, and the social good.

Questions about the nature of intelligence and intelligence testing have sparked increasing controversy during the past two decades. The widely held view that intelligence is measurable, and both genetic endowment and environment are key determinants of intelligence, first came under sharp attack during the decade of the 1960s. It was asserted that we do not know what intelligence is, that we do not know how to measure intelligence, and that IQ tests are biased against both minorities and the poor. To determine current opinions among the relevant scientific communities on these issues, the authors used survey research to sample a broad group of experts in educational and developmental psychology as well as those whose specific expertise is intelligence testing. They found that, despite the common understanding to the contrary, most experts continue to believe that intelligence can be measured and that genetic endowment plays an important role in IQ. The central question addressed in this book is why expert opinion and public views toward intelligence and its measurement are so widely divergent. The authors conclude that the public's view of the IQ controversy has been shaped by inaccurate media coverage; and, more importantly, by changes in the nature of American liberalism as well as the key role of civil rights issues in American life. The increasing influence of new strategic elites in the United States, and the changing role of the mass media, have profoundly affected the character of scientific information communicated to the general public and how it is communicated.
