This is an introduction to linear algebra. The main part of the book features row operations and everything is done in terms of the row reduced echelon form and specific algorithms. At the end, the more abstract notions of vector spaces and linear transformations on vector spaces are presented. However, this is intended to be a first course in linear algebra for students who are sophomores or juniors who have had a course in one variable calculus and a reasonable background in college algebra. I have given complete proofs of all the fundamental ideas, but some topics such as Markov matrices are not complete in this book but receive a plausible introduction. The book contains a complete treatment of determinants and a simple proof of the Cayley Hamilton theorem although these are optional topics. The Jordan form is presented as an appendix. I see this theorem as the beginning of more advanced topics in linear algebra and not really part of a beginning linear algebra course. There are extensions of many of the topics of this book in my on line book. I have also not emphasized that linear algebra can be carried out with any field although there is an optional section on this topic, most of the book being devoted to either the real numbers or the complex numbers. It seems to me this is a reasonable specialization for a first course in linear algebra.

After a few drinks at one of the watering holes in Wan Chai district of Hong Kong, Kwong-Sang Cheng was in very hiRh spirit and volunteered to taking on the responsibility of hosting the 51 Pacific Rim Conference at Hong Kong University in 1999.

This book has developed from courses given by the authors and probably contains more material than will ordinarily be covered in a one-year course. It is hoped that the book will be a useful text in the application of differential equations as well as for the pure mathematician. Prerequisite for this book is a knowledge of matrices and the

essentials of functions in a complex variable. The book thoroughly addresses linear equations, and touches on the use of the Riemann-Stieltjes integral, and the Lebesgue integral, and the theorems required from integration theory. The problems, in some cases, give additional material not considered in the text.

This is part one of a two-volume book on real analysis and is intended for senior undergraduate students of mathematics who have already been exposed to calculus. The emphasis is on rigour and foundations of analysis. Beginning with the construction of the number systems and set theory, the book discusses the basics of analysis (limits, series, continuity, differentiation, Riemann integration), through to power series, several variable calculus and Fourier analysis, and then finally the Lebesgue integral. These are almost entirely set in the concrete setting of the real line and Euclidean spaces, although there is some material on abstract metric and topological spaces. The book also has appendices on mathematical logic and the decimal system. The entire text (omitting some less central topics) can be taught in two quarters of 25–30 lectures each. The course material is deeply intertwined with the exercises, as it is intended that the student actively learn the material (and practice thinking and writing rigorously) by proving several of the key results in the theory.

The classical applications and computational methods that are responsible for much of the interest and importance of calculus are also considered. This text is organized into six chapters. Chapter I deals with linear algebra and geometry of Euclidean n -space R_n . The multivariable differential calculus is treated in Chapters II and III, while multivariable integral calculus is covered in Chapters IV and V. The last chapter is devoted to venerable problems of the calculus of variations. This publication is intended for students who have completed a standard introductory calculus sequence.

This book gives a self-contained treatment of linear algebra with many of its most important applications. It is very unusual if not unique in being an elementary book which does not neglect arbitrary fields of scalars and the proofs of the theorems. It will be useful for beginning students and also as a reference for graduate students and

others who need an easy to read explanation of the important theorems of this subject. It presents a self-contained treatment of the algebraic treatment of linear differential equation which includes all proofs. It also contains many different proofs of the Cayley Hamilton theorem. Other applications include difference equations and Markov processes, the latter topic receiving a more thorough treatment than usual, including the theory of absorbing states. In addition it contains a complete introduction to the singular value decomposition and related topics like least squares and the pseudo-inverse. Most major topics receive more than one discussion, one in the text and others being outlined in the exercises. The book also gives directions for using maple in performing many of the difficult algorithms.
