

## Chapter 1 The Group Work Tradition In Social Work

In this book, Steven R Rose presents the concepts, context and applications of a problem-solving approach to group work with children and adolescents who suffer from a wide range of social problems. The book addresses issues associated with assessment, problem recognition, planning and composition, leadership and activities in a wide range of settings. Phases of group work, practice guidelines and evaluation are also thoroughly considered.

Written primarily for occupational therapists, this text explores the range of group-work activities used within occupational-therapy practice. The first part tackles theoretical aspects, while the second considers practical approaches to group management. There are specific chapters on how to plan, lead and evaluate a group, and guidelines are provided on how to approach some of the common problems which arise in group work.
