The reaction of power systems to GMDs and mitigation strategies aiming at reducing and controlling the risks are then addressed. The GMD mitigation strategies, the power systems critical factors analysis, the high-risk zones identification and an estimation of economic loss, which is a valuable input for the (re)insurance sector, are also brought to the attention of the reader. Cratonic basins are large, distinctive features of the continental crust. They are preferentially developed on thick continental lithosphere, are typically sub-circular in shape and subside over periods of hundreds of millions of years. They are also endowed with significant resources. However, in spite of their location in continental interiors and often well-known geology, the subsidence driving mechanism and tectonic setting of these basins remains controversial. This volume presents both lithospheric and basin scale datasets acquired specifically to interrogate the tectonic process of cratonic basin formation. Focused on the Silurian to Triassic Parnaíba cratonic basin of Brazil, the papers discuss the results of a multidisciplinary basin analysis project comprising new geophysical, geological and geochemical data. This unique dataset enables the characterization of the lithospheric crust and mantle beneath the Parnaíba Basin, constrains the detailed evolution of the basin itself, and enables comparisons with cratonic basins globally. Several convergent themes emerge providing new and powerful constraints for models of the driving mechanisms of these enigmatic basins. Motivated by the importance of electrical resistivity and conductivity, important experts in this field grasp most recent researches in this book. It addresses recent advances in electrical resistivity and conductivity modelling, measurement, estimation and sensing methods and implications. The magnetotelluric method is a technique for imaging the electrical conductivity and structure of the Earth, from the near surface down to the 410 km transition zone and beyond. Technical issues, instrumentation and field practices are described for both land and marine surveys. This book provides a rigorous introduction to magnetotellurics for academic researchers and advanced students and will be of interest to industrial practitioners and geoscientists wanting to incorporate rock conductivity into their interpretations.

Instrumentation is central to the study of physiology and genetics in living organisms, especially at the molecular level. Numerous techniques have been developed to address this in various biological disciplines, creating a need to understand the physical principles involved in the operation of research instruments and the parameters required in using them. Introduction to Instrumentation in Life Sciences fills this need by addressing different aspects of tools that hold the keys to cutting-edge research and innovative applications, from basic techniques to

advanced instrumentation. The text describes all topics so even beginners can easily understand the theoretical and practical aspects. Comprehensive chapters encompass well-defined methodology that describes the instruments and their corresponding applications in different scientific fields. The book is designed to serve a wide range of students and researchers in diversified fields of life sciences: pharmacy, biotechnology, microbiology, biochemistry, and environmental sciences. It introduces different aspects of basic experimental methods and instrumentation. The book is unique in its broad subject coverage, incorporating fundamental techniques as well as applications of modern molecular and proteomic tools that are the basis for state-of-the-art research. The text emphasizes techniques encountered both in practical classes and in high-throughput environments used in modern industry. As a further aid to students, the authors provide well-illustrated diagrams to explain the principles and theories behind the instruments described.

Electricity in Fish Research and Management, 2nd Edition provides a comprehensive discussion of the uses of both electricity and electrical principles in fishery management and research. It covers electric fishing (including theory, equipment, data analysis and practical factors affecting efficiency), fish barriers, fish counters and fish welfare issues. The book concentrates on Electric Fishing (or Electrofishing); an internationally accepted and widely used procedure for sampling fish. Over the past 50 years electric fishing has become a standard method for fishery studies and management e.g. establishing population densities and abundance. However, due to the potential hazards of the method (both to operators and fish) there is a continuing need to develop and promote best practice guidelines. The author has studied fish ecology for 40 years and understands the need for information that reaches out to all levels of understanding in the field. Previous books on this subject have either been collections of scientific papers and/or technical reports or very simple instruction manuals. In this book theory and practice is explained using non-technical language and simple equations. It brings depth as well as breadth in both information and principles behind the methods and should be an invaluable tool to both fisheries managers and researchers. Although the book is aimed at undergraduates, the clear explanation of the factors means that the book is suitable for all levels of practitioners.
