Following the stock market crash of 1929 and the ensuing Great Depression, Fisher developed a theory of economic crises called "debt-deflation," which rejected general equilibrium theory and attributed crises to the bursting of a credit bubble. According to the debt deflation theory, a sequence of effects of the debt bubble bursting occurs: 1. Debt liquidation and distress selling. 2. Contraction of the money supply as bank loans are paid off. 3. A fall in the level of asset prices. 4. A still greater fall in the net worth of businesses, precipitating bankruptcies. 5. A fall in profits. 6. A reduction in output, in trade and in employment. 7. Pessimism and loss of confidence. 8. Hoarding of money. 9. A fall in nominal interest rates and a rise in deflation adjusted interest rates. This theory was ignored in favor of Keynesian economics, partly due to the damage to Fisher's reputation from his overly optimistic attitude prior to the crash, but has experienced a revival of mainstream interest since the 1980s, particularly since the Late-2000s recession, and is now a main theory with which he is popularly associated.

The late twentieth century has witnessed a dramatic upsurge in foreign direct investment in the Third World. This edition includes an introduction by Jeffrey Seitzer and Christopher Thornhill outlining the cultural, intellectual, and political contexts in which Schmitt wrote *Constitutional Theory*; they point out what is distinctive about the work, examine its reception in the postwar era, and consider its larger theoretical ramifications. This volume also contains extensive editorial notes and a translation of the Weimar Constitution.

America's high incarceration rates are a well-known facet of contemporary political conversations. No previous knowledge of data communications and related fields is required for understanding this text. Two chapters serve as introductions to the Simple Network Management Protocol (SNMP) and Remote Monitoring (RMON). This text includes also five appendices with very useful information on how computers use numbers to condition and distribute data from source to destination, and a design example to find the optimum path for connecting distant facilities. Each chapter includes True-False, Multiple-Choice, and problems to test the reader's understanding. Answers are also provided.
