When it became clear that they would miss the pole, Nansen and his companion Hjalmar Johansen struck off by themselves. Racing the shrinking pack-ice, they attempted, by dog-sled, to go "farthest north." They survived a winter in a moss hut eating walrus and polar bears, and the public assumed they were dead. In the spring of 1896, after three years of trekking, and having made it to
