When the Supreme Court announced its ruling in *Massachusetts v. EPA*, the decision was immediately hailed as a landmark. But this was the farthest thing from anyone's mind when Joe Mendelson, an idealistic lawyer working on a shoestring budget for an environmental organization no one had heard of, decided to press his quixotic case. In October 1999, Mendelson hand-delivered a petition to the Environmental Protection Agency asking it to restrict greenhouse gas emissions from new cars.
