Made of roughly 95 percent water, some jellies are barely perceptible virtuosos of disguise, while others glow with a luminescence that has revolutionized biotechnology. Yet until recently, jellyfish were largely ignored by science, and they remain among the most poorly understood of ocean dwellers. More than a decade ago, Juli Berwald left a career in ocean science to raise a family in landlocked Austin, Texas, but jellyfish drew her back to the sea. Recent, massive blooms of billions of jellyfish have clogged power plants, decimated fisheries, and caused millions of dollars of damage. Driven by questions about how overfishing, coastal development, and climate change were contributing to a jellyfish population explosion, Juli embarked on a scientific odyssey. She traveled the globe to meet the biologists who devote their careers to jellies, hitched rides on Japanese fishing boats to see giant jellyfish in the wild, raised jellyfish in her dining room, and throughout it all marveled at the complexity of these alluring and ominous biological wonders. Gracefully blending personal memoir with crystal-clear distillations of science, *Spineless* is the story of how Juli learned to navigate and ultimately embrace her ambition, her curiosity, and her passion for the natural world. She discovers that jellyfish science is more than just a quest for answers. It's a call to realize our collective responsibility for the planet we share.

At various times in a span of fifteen years, John McPhee made geological field surveys in the company of Eldridge Moores, a tectonicist at the University of California at Davis. The result of these trips is *Assembling California*, a cross-section in human and geologic time, from Donner Pass in the Sierra Nevada through the golden foothills of the Mother Lode and across the Great Central Valley to the wine country of the Coast Ranges, the rock of San Francisco, and the San Andreas family of faults. The two disparate time scales occasionally intersect—in the gold disruptions of the nineteenth century no less than in the earthquakes of the twentieth—and always with relevance to a

newly understood geologic history in which half a dozen large and separate pieces of country are seen to have drifted in from far and near to coalesce as California. McPhee and Moores also journeyed to remote mountains of Arizona and to Cyprus and northern Greece, where rock of the deep-ocean floor has been transported into continental settings, as it has in California. Global in scope and a delight to read, *Assembling California* is a sweeping narrative of maps in motion, of evolving and dissolving lands. The science of geology was constructed in the decades around 1800 from earlier practices that had been significantly different in their cognitive goals. In the studies collected here Martin Rudwick traces how it came to be recognised as a new kind of natural science, because it was constituted around the idea that the natural world had its own history. The earth had to be understood not only in relation to unchanging natural laws that could be observed in action in the present, but also in terms of a pre-human past that could be reliably known, even if not directly observable and its traces only fragmentarily preserved. In contrast to this radically novel sense of nature's own contingent history, the earth's unimaginably vast timescale was already taken for granted by many naturalists (though not yet by the wider public), and the concurrent development of biblical scholarship precluded any significant sense of conflict with religious tradition. learning models to combine predictions of global climate models using information from spatial and temporal patterns is also explored. The problem of using large-scale machine learning to study the formation of tornadoes is also explored in depth.
