semester introduction to analysis. The prerequisites are a good grounding in the calculus of one variable from a mathematically rigorous point of view, together with some acquaintance with linear algebra. The reader should be familiar with limit and continuity type arguments and have a certain amount of mathematical sophistication. As possible introductory texts, we mention Differential and Integral Calculus by R Courant, Calculus by T Apostol, Calculus by M Spivak, and Pure Mathematics by G Hardy. The reader should also have some experience with partial derivatives. This book is based on a first-year graduate course I gave three times at the University of Chicago. As it was addressed to graduate students who intended to specialize in mathematics, I tried to put the classical theory of functions of a complex variable in

context, presenting proofs and points of view which relate the subject to other branches of mathematics. Complex analysis in one variable is ideally suited to this attempt. Of course, the branches of mathematics one chooses, and the connections one makes, must depend on personal taste and knowledge. My own leaning towards several complex variables will be apparent, especially in the notes at the end of the different chapters. The first three chapters deal largely with classical material which is available in the many books on the subject. I have tried to present this material as efficiently as I could, and, even here, to show the relationship with other branches of mathematics. Chapter 4 contains a proof of Picard's theorem; the method of proof I have chosen has far-reaching generalizations in several complex variables and in differential geometry. The next two chapters deal with the Runge approximation theorem and its many applications. The presentation here has been strongly influenced by work on several complex variables.

Fundamentals of Mathematical Analysis is an extensive study of metric spaces, including the core topics of completeness, compactness and function spaces, with a good number of applications. The later chapters consist of an introduction to general topology, a classical treatment of Banach and Hilbert spaces, the elements of operator theory, and a deep account of measure and integration theories. Several courses can be based on the book. This book is suitable for a two-semester course on analysis, and material can be chosen to design one-semester courses on topology or real analysis. It is designed as an accessible classical introduction to the subject and aims to achieve excellent breadth and depth and contains an abundance of examples and exercises. The topics are carefully sequenced, the proofs are detailed, and the writing style is clear and concise. The only prerequisites assumed are a thorough understanding of undergraduate real analysis and linear algebra, and a degree of mathematical maturity.

This book is intended as a textbook for a first course in the theory of functions of one complex variable for students who are mathematically mature enough to understand and execute $\epsilon - \delta$ arguments. The actual prerequisites for reading this book are quite minimal; not much more than a stiff course in basic calculus and a few facts about partial derivatives. The topics from advanced calculus that

are used (e.g., Leibniz's rule for differentiating under the integral sign) are proved in detail. Complex Variables is a subject which has something for all mathematicians. In addition to having applications to other parts of analysis, it can rightly claim to be an ancestor of many areas of mathematics (e.g., homotopy theory, manifolds). This view of Complex Analysis as "An Introduction to Mathematics" has influenced the writing and selection of subject matter for this book. The other guiding principle followed is that all definitions, theorems, etc.

The authors try to rely on as few concepts from real analysis as possible. In particular, series and sequences are treated from scratch.
