

Ics Bridge Procedures Guide

This book focuses on the interaction between shipping and the natural environment and how shipping can strive to become more sustainable. There are no geographical limitations to the maritime jurisdiction on shore other than the limitations of the Occupational Safety and Health Act itself.
