Christian Missionaries worked hard to convert immigrants. Their first order of business was to denigrate Hinduism, designate Hindus as heathen, and disparage their culture, food and even attire. Immigrants stubbornly resisted, led by the tiny educated elite, including Brhmaas whom we call Brahmins. Conversion was a failure at least up to the end of the 19th century but picked up a self-generating momentum thereafter. The result is that the share of Hindus in Guyana's Indian population declined from 83.5 percent in 1880 to 62.8 percent in 2012. The largest portion of the contraction was lost to Christianity. The loss notwithstanding, even a casual observer would conclude that Guyanese Hindus, at home and in the Diaspora, are a very religious people. Many of us do a jhandi or havan once annually; others do the more elaborate and costlier yajña, where everyone is welcome, once or twice in their lifetime. Most of us do a short daily puja – prayers, offerings, reading the stras and listening to bhajan – in our homes. An important, but perhaps unintended, way immigrants countered conversion to Christianity was an unplanned movement towards a “synthesis” that brought Hindus, regardless of caste or sect, under a “unitary form of Hinduism.” The “synthesis” began around the 1870s and was completed by the 1930s to the 1950s. Guyanese Hindus call the unified corpus of religious beliefs and practices that emerged from the “synthesis” Sanatana Dharma. Ramesh Gampat labels it Plantation Hinduism in this path-breaking

book. The book argues that the brand of Hinduism practiced is inconsistent with Sanatana Dharma, called Vednta by the more philosophically inclined. Plantation Hinduism features an extraordinary dependence upon purohits (pandits), which has anaesthetized the Hindu mind and render him unable to think, question and inquire when it comes to Dharma. Rituals and bhakti have been degraded and turned into desire-motivated worship; devats have been misconstrued as Brahman rather than as limited manifestation of the one non-dual pure Consciousness; belief in the multiplicity of gods encourages image worship; and superstitions anchor Guyanese Hindus to tradition and mere belief. Plantation Hinduism is little more than desire-motivated actions, dogmas and superstitions. Absent is the idea that Sanatana Dharma is a spiritual science no less scientific than hard sciences, such as physics and astronomy. The central message of Vednta is the innate divinity of every person and the freedom to realize that divinity through anubhava, direct personal experience of Supreme Reality.

'Religion is a tool in the hands of the oppressor against the oppressed solely because he frames the commandments and calls them the God's', is an apt description of the Hindu social order. The author boldly analyses this imbroglio through a microscopic analysis of these and more related issues: • How priests controlled the Hindu religious, social, educational and political apparatus? • How the dominant priestly class fractured the society into mutually antagonistic subordinated hierarchical segments, and ruled it by reserving all elite jobs for itself? • How the fiendish priesthood emasculated shudras by depriving them of the 'shastra and shastra' (education and arms) and made them permanent 'village servant classes'? • How the pretensions of attaining siddhis through 'meditation and penances' established priests as the 'gods on earth' for their assertions of 'purity and effulgence'? • How 'karma', 'reincarnation' and '84-lakhs births' theories were devised to justify fatalism and hierarchical gradation of varnas? • Can India be rightfully called the 'vishvaguru' and the mother of all civilisations? • How Buddhism effeminated Hindus and made them the doormats for the ruthless? • Why Hindus had to abandon their own, to adop foreign institutions of governance? • Why Hinduism should become a universal and proselytising faith and fight demographic challenges posed by Islam and Christianity?

It has additional data on the use of financial technology (or fintech),

including the use of mobile phones and the Internet to conduct financial transactions. The data reveal opportunities to expand access to financial services among people who do not have an account—the unbanked—as well as to promote greater use of digital financial services among those who do have an account. The Global Findex database has become a mainstay of global efforts to promote financial inclusion. In addition to being widely cited by scholars and development practitioners, Global Findex data are used to track progress toward the World Bank goal of Universal Financial Access by 2020 and the United Nations Sustainable Development Goals. The database, the full text of the report, and the underlying country-level data for all figures—along with the questionnaire, the survey methodology, and other relevant materials—are available at www.worldbank.org/globalindex.

Hindu nationalists in the west Indian state of Gujarat repudiate the pluralist vision of Gandhi and Nehru and foment state-sponsored violence and ethnic cleansing against Muslims and Christians. In 2002, the burning to death of 59 rightwing Hindu militants in a train in Gujarat set off waves of state-condoned communal riots in which as many as 2,000 predominantly Muslim Gujaratis were murdered and 200,000 made homeless. In the wake of these atrocities, secular peace-building organizations have redoubled their efforts to heal the rift between Hindus and Muslims in Gujarat. A certified mediator, Janet Powers bases her book on interviews with workers in twenty of these peace-building NGOs and grassroots peace organizations, which are locked in struggle with politicized Hindu religious organizations largely funded by money raised in the United States. This is the first book to examine Hindu-Muslim relations in Gujarat in the frame of ongoing peace and conflict resolution efforts. Gujarat is the state of origin of most of the entrepreneurial Indians who own motels, convenience stores, and gas stations in the United States and United Kingdom. Much of the funding for the rightwing Hindu parties that foment extremist violence, ethnic cleansing, and re-conversion campaigns against the Muslim and Christian minorities in Gujarat comes from Gujarati expatriates in the U.S. and UK. Gujarat is the home of Mahatma Gandhi, who was assassinated in 1948 by an agent of the RSS, a violently anti-Muslim Hindu nationalist organization that flourishes today in Gujarat in virulent association with the ruling BJP and VHP parties. Equally dangerous to the peace of Gujarat are violent Wahhabist organizations based in Pakistan but operating in India. Powers assesses the prospects for long-term healing in Gujarat based on historical precedents, and she applies the lessons of Gujarati grassroots peace-building organizations in Gujarat to zones of state-sponsored religious conflict in other parts of the world.

Kenya, Uganda and Tanzania have minorities from the Indian sub-continent amongst their population. The East African Indians mostly reside in the main cities, particularly Nairobi, Dar es Salaam, Zanzibar, Mombasa, Kampala; they can also be found in smaller urban centres and in the remotest of rural townships. They play a leading social and economic role as they work in business, manufacturing and the service industry, and make up a large proportion of the liberal professions. They are divided into multiple socio-religious communities, but united in a mutual feeling of meta-cultural identity.
