We examine the association between capital inflows and industry growth in a sample of 22 emerging market economies from 1998 to 2010. We expect more external finance dependent industries in countries that host more capital inflows to grow disproportionately faster. This is indeed the case in the pre-crisis period of 1998–2007, and is driven by debt, rather than equity, inflows. We also observe a reduction in output volatility but this association is more pronounced for equity, rather than debt, inflows. In line with this observation, we also document that the inflows-growth nexus is stronger in countries with well-functioning banks.

This richly illustrated collection profiles the bold innovators in landscape architecture who, around the turn of the twentieth century, ventured into the nation's heartland to develop a new style of design celebrating the native midwestern landscape. The pioneers of landscape architecture in the Midwest are responsible for creating some of the most recognizable parks, cemeteries, recreation areas, and other public gathering places in the region. Midwestern Landscape Architecture includes essays on Adolph Strauch, who introduced a new concept of visually integrated landscape treatment in Cincinnati's Spring Grove Cemetery; William Le Baron Jenney, designer of Chicago's diverse West

Parks; and Jens Jensen, who created the American Garden in Union Park in Chicago (a celebration of native flora) and founder of The Clearing, a unique school of the arts and humanities in Wisconsin.
