La protezione dell'ambiente, la tutela delle risorse ecologiche e naturali, la valorizzazione sostenibile degli spazi urbani e rurali rappresentano per le società del terzo millennio degli incontestabili paradigmi etici e delle ineludibili realtà con le quali confrontarsi. The C-ORAL-ROM book and DVD provide a unique set of comparable corpora of spontaneous speech for the main Romance languages, French, Italian, Portuguese and Spanish.
