10. Fasts serve as sentinel against evils and sins.
11. Fasts inspire Islamic spirit and zeal to do virtuous deeds.
12. Observance of fast is secret and quiet worship which is free from show and hypocrisy.
13. Fast is an effective source of warding off calamities and disasters.
