Contributed articles presented at the first National Conference of Indian Distance Education Association (IDEA) held at the School of Distance Learning and Continuing Education, Kakatiya University, Warangal during 3-5 Nov., 1993.

The evolution of distance education in India in forms of dual mode, single mode and consortia has been phenomenal. The system today is one of the largest distance education networks in the world comprising dual mode university distance education institutes, single mode open universities, dual mode secondary education, single mode open schools, distance education council/consortium, and many private and semi-government providers of education and training. The four generations of distance education have been implemented in a variety of forms and models, and the system exhibits adoption of innovative practices in course design, development, delivery, evaluation, media networking, and planning and management which have proved effective in addressing the issues of access and equity, economy, quality and reform in the country, and which have been adapted/emulated by a host of such systems in the developing world. It is, therefore, imperative at this stage to reflect on the developments of above four decades of distance education in this country, and map its future expansion. Each chapter in the volume reflects on the concerned theme covering the distance education system in the country, traces the limitations and adoption of innovative strategies to address the issues, and introspect on its future possibilities.

The book, packed in 22 chapters, provides in-depth and detailed information on different aspects of urban development. Issues, such as education, health, power, transport, stray animals, tourism, water, greenery, pollution, waste and sanitation management, disaster management, adulteration, crimes, social life, civic infrastructure, encroachment, unauthorized construction and illegal colonies, which the people in Delhi have been confronting for long, have been covered under the book. As Delhi is the national capital and the mirror of the country, the author has attempted to focus on the development of it as a role model of the urban India, to be replicated by others in respect of issues that affect the day-to-day life of a common man, people of all age groups, sex, religion, region, poor and rich, students, public and private sectors, bureaucrats, businessmen, industrialists and politicians. The book will be of immense value to policymakers, programme planners, public and private sectors, NGOs, social workers, environmental workers, educationists, developmental practitioners and the Delhiites who dream to see Delhi as "a world-class city".

Most of us have been victims of frauds and related crimes at some point or the other in our lives. We may not have answers to pertinent questions such as: Who is responsible for the fraud committed? Why do people commit white collar crimes? What makes us vulnerable to such crimes? Who could have prevented the crime? What could individuals and entities do to prevent the crime in future and what action should we take to recover the losses? Unlike street crimes where victims are clearly identified and their losses and concerns are suitably recorded and attended to, the victims of White Collar Crimes are not given proper attention and many times such crimes are considered to be 'victim less'. This book attempts to examine the above questions by analyzing various types of white collar crimes, drawing examples of such crimes that have happened across the world. History reveals that crimes travel across the globe in time as criminals learn from each other for their criminal indulgences. We hear about a crime elsewhere – in a different city or a country - and within no time you find the same thing happening with necessary improvisation in our own neighborhood. When the corporate criminals, opportunist and greedy public servants join hands, to indulge in various types of crimes, the regulatory enforcement becomes lax, farce and ineffective. In the end, the victims – the public who were adversely impacted, the shareholders who lost their investments, the consumers who got a raw deal, the employees who lost their jobs and the financiers who lost what they lent – suffer without any recourse. The book culminates with two chapters exclusively on answering questions such as - Why do people commit white collar crime? Why do people fall victim to white collar crime and how to curb this menace? The book concludes with an analysis of whistleblowers and the related challenges and safeguards. As scams and frauds perpetuate, there is a need for a systematic analysis of the pattern, the impact and the preventive steps. The insights given in the book would be helpful for professionals as well as common citizens.
