Visually evocative and ideologically representative, flags are recognized symbols fusing color with meaning that prescribe a story of unity. Knowing this and their function, the book investigates these transmitted values over time and space. Indeed, flags may have evolved in key historical periods, but contemporaneously transpire in a variety of ways. The book investigates these transmitted values: Which values are being transmitted? Have their colors
