

## Professional Ethics Kaplan

Ethics for the Insurance Professional teaches the broad parameters of a life insurance agent's ethical responsibilities. It details the agent's responsibility to the insurer, to policyowners, and to the public and outlines fiduciary issues. The Helping Professional's Guide to Ethics, Second Edition develops a comprehensive framework for ethics based on Bernard Gert's theory of common morality.
