It is not an exaggeration to view Professor Lee's book, "Software Engineering with Computational Intelligence," or SECI for short, as a pioneering contribution to software engineering. As its title suggests, SECI employs the machineries of computational intelligence (CI) and, more or less equivalently, soft computing (SC), to deal with the foundations and principal issues in software engineering. Basically, CI and SC are consortia of methodologies which collectively provide a body of concepts and techniques for conception, design, construction and utilization of intelligent systems. The principal constituents of CI and SC are fuzzy logic, neurocomputing, evolutionary computing, probabilistic computing, chaotic computing and machine learning. The leitmotif of CI and SC is that, in general, better performance can be achieved by employing the constituent methodologies of CI and SC in combination rather than in a stand-alone mode. In what follows, I will take the liberty of focusing my attention on fuzzy logic and fuzzy set theory, and on their roles in software engineering. But first, a couple of points of semantics which are in need of clarification.
