Concrete Structures provides an easy-to-understand, integrated and comprehensive treatment of the behaviour, analysis and design of reinforced concrete and prestressed concrete structures. Concrete Structures is the definitive Australia textbook on concrete structures for students and professionals.

Designed primarily as a text for the undergraduate students of civil engineering, this compact and well-organized text presents all the basic topics of reinforced concrete design in a comprehensive manner. The text conforms to the limit states design method as given in the latest revision of Indian Code of Practice for Plain and Reinforced Concrete, IS: 456 (2000). This book covers the applications of design concepts and provides a wealth of state-of-the-art information on design aspects of wide variety of reinforced concrete structures. However, the emphasis is on modern design approach. The text attempts to:

- Present simple, efficient and systematic procedures for evolving design of concrete structures.
- Make available a large amount of field tested practical data in the appendices.
- Provide time saving analysis and design aids in the form of tables and charts.
- Cover a large number of worked-out practical design examples and problems in each chapter.
- Emphasize on development of structural sense needed for proper detailing of steel for integrated action in various parts of the structure.

Besides students, practicing engineers and architects would find this text extremely useful.

Structural Analysis, or the 'Theory of Structures', is an important subject for civil engineering students who are required to analyze and design structures. It is a vast field and is largely taught at the undergraduate level. The initial three chapters review the basic concepts in structural analysis and matrix algebra, and show how the latter provides an excellent mathematical framework for the former. The next three chapters discuss in detail and demonstrate through many examples how matrix methods can be applied to linear static analysis of skeletal structures (plane and space trusses; beams and grids; plane and space frames) by the stiffness method. Also, it is shown how simple structures can be conveniently solved using a reduced stiffness formulation, involving far less computational effort. The flexibility method is also discussed. Finally, in the seventh chapter, analysis of elastic instability and second-order response is discussed in detail. The main objective is to enable the student to have a good grasp of all the fundamental issues in these advanced topics in Structural Analysis, besides enjoying the learning process, and developing analytical and intuitive skills. With

these strong fundamentals, the student will be well prepared to explore and understand further topics like Finite Elements Analysis.
