The practical need to partition the world of viruses into distinguishable, universally agreed upon entities is the ultimate justification for developing a virus classification system. Since 1971, the International Committee on Taxonomy of Viruses (ICTV) operating on behalf of the world community of virologists has taken on the task of developing a single, universal taxonomic scheme for all viruses infecting animals (vertebrate, invertebrates, and protozoa), plants (higher plants and algae), fungi, bacteria, and archaea. The current report builds on the accumulated taxonomic construction of the eight previous reports dating back to 1971 and records the proceedings of the Committee since publication of the last report in 2005. Representing the work of more than 500 virologists worldwide, this report is the authoritative reference for virus organization, distinction, and structure.

This book is concerned with the topical problems of mechanics of advanced composite materials whose mechanical properties are controlled by high-strength and high-stiffness continuous fibers embedded in polymeric, metal, or ceramic matrix. Although the idea of combining two or more components to produce materials with controlled properties has been known and used from time immemorial, modern composites were only developed several decades ago and have now found intensive application in different fields of engineering, particularly in aerospace structures for which high strength-to-weight and stiffness-to-weight ratios are required. There already exist numerous publications that cover anisotropic elasticity, mechanics of composite materials, design, analysis, fabrication, and application of composite structures but the difference between this book and the existing ones is that this is of a more specific nature. It covers specific features of material behaviour such as nonlinear elasticity, plasticity, creep, and structural nonlinearity and discusses in detail the problems of material micro- and macro-mechanics that are only slightly touched in existing books, e.g. stress diffusion in a unidirectional material with broken fibers, physical and statistical aspects of fiber strength, coupling effects in anisotropic and laminated materials, etc. The authors are designers of composite structures who were involved in practically all the main Soviet and then Russian projects in composite technology, and the permission of the Russian Composite Center - Central Institute of Special Machinery (CRISM) to use in this book the pictures of structures developed and fabricated in CRISM as part of the joint research and design project is much appreciated. Mechanics and Analysis of Composite Materials consists of eight chapters progressively covering all structural levels of composite materials from their components through elementary plies and layers to laminates.

A few books bearing the title of biomechanics are too elementary, others are too specialized.

We cannot assume that all students come to biomechanics already fully trained in fluid and solid mechanics; their knowledge in these subjects has to be developed as the course proceeds. The scheme adopted in the present series is as follows. First, some basic training in mechanics, to a level about equivalent to the first seven chapters of the author's *A First Course in Continuum Mechanics* (Prentice-Hall, Inc. 1977), is assumed. We then present some essential parts of biomechanics from the point of view of bioengineering, physiology, and medical applications. In the meantime, mechanics is developed through a sequence of problems and examples. The main text reads like physiology, while the exercises are planned like a mechanics textbook. The instructor may fill a dual role: teaching an essential branch of life science, and gradually developing the student's knowledge in mechanics.

Algebraic geometry has benefited enormously from the powerful general machinery developed in the latter half of the twentieth century. The cost has been that much of the research of previous generations is in a language unintelligible to modern workers, in particular, the rich legacy of classical algebraic geometry, such as plane algebraic curves of low degree, special algebraic surfaces, theta functions, Cremona transformations, the theory of apolarity and the geometry of lines in projective spaces. New textbooks at all levels of chemistry appear with great regularity. Some fields like basic biochemistry, organic reaction mechanisms, and chemical thermodynamics are well represented by many excellent texts, and new or revised editions are published sufficiently often to keep up with progress in research. However, some areas of chemistry, especially many of those taught at the graduate level, suffer from a real lack of up-to-date textbooks. The most serious needs occur in fields that are rapidly changing. Textbooks in these subjects usually have to be written by scientists actually involved in the research which is advancing the field. It is not often easy to persuade such individuals to set time aside to help spread the knowledge they have accumulated. Our goal, in this series, is to pinpoint areas of chemistry where recent progress has outpaced what is covered in any available textbooks, and then seek out and persuade experts in these fields to produce relatively concise but instructive introductions to their fields. These should serve the needs of one semester or one quarter graduate courses in chemistry and biochemistry. In some cases, the availability of texts in active research areas should help stimulate the creation of new courses.
