In northern India, the diverse physiography of the state of Jammu and Kashmir, situated in the western Himalayas, exhibits the shape of a terrace having three steps of increasing elevation from south to north. The lower step comprises the sub-Himalayan Jammu, the middle is Himalayan Kashmir, and the upper as trans-Himalayan Ladakh. This varied surface configuration makes these regions quite distinct where Jammu is mostly hilly; Kashmir, a sizeable plain surrounded by mountains; and Ladakh, an area of towering landforms.
