BIOGRAPHY & AUTOBIOGRAPHY: HISTORICAL, POLITICAL & MILITARY. This is a major biography of Henry's VIII's right hand man, revealing for the first time that the image of a blood stained henchman is largely fictional. Thomas Cromwell was the Henry's VIII's chief minister and principal reformer of the church in one of the most eventful eras in English history.

Thomas Cromwell, chief architect of the English Reformation, served as minister of Henry VIII from 1531 to 1540, the period during which more political and religious reform was accomplished than at any other time in Henry's thirty-seven-year reign. Thus the momentous events of the 1530s are generally (but not universally) attributed to Cromwell's agency. Cromwell has been the subject of close and continuous attention for the last half century, with positive appraisal of his work and achievements as the scholarly norm. In this classroom biography-the first in a generation and the only one now in print-that judgment is largely accepted, though it is combined with earlier and more critical assessments that view Cromwell as a disciple of Machiavelli. One distinguishing feature of this study is its overview of Machiavellian thought, along with its overview of Marsilian thought. Marsilius of Padua, fourteenth-century political philosopher and author of Defensor Pacis, is widely recognized as the source of

Cromwell's reformation ideas; but nowhere is Marsilius explicated. The same is true of Machiavelli-never explicated though said to be (by Reginald Pole, cousin of Henry and cardinal of the church) the source of Cromwell's ideas on statecraft. A second distinguishing feature of the book is its inclusion of an introductory chapter that situates Cromwell in the sixteenth century and shows his connection to important events, characters, and ideas. Thus, while the book is a biography, its focus is broader and its uses more various.

King-makers - Conspirators - Criminals - Nobles - Seducers The Howard family - the Dukes of Norfolk - were the wealthiest and most powerful aristocrats in Tudor England,

regarding themselves as the true power behind the throne. They were certainly extraordinarily influential, with two Howard women marrying Henry VIII - Anne Boleyn and the fifteen-year-old Catherine Howard. But in the treacherous world of the Tudor court no faction could afford to rest on its laurels. The Howards consolidated their power with an awesome web of schemes and conspiracies but even they could not always hold their enemies at bay. This was a family whose history is marked by treason, beheadings and incarceration - a dynasty whose pride and ambition secured only their downfall.

The Tudors retained only a precarious grip on the crown of England, founded on a title that was both tenuous and legally flimsy. This left them preoccupied by two major obsessions: the necessity for a crop of lusty male heirs to continue their bloodline, and the elimination of threats from those who had strong, if not superior, claims to the throne than them. None was cursed more by this rampant insecurity than Henry VIII. The king embodied not only the power and imperial majesty of the monarchy, but also England's stature and military might. His health always had huge political consequences at home and overseas - hence his unbridled hypochondria. Henry's last six years saw him embark on two marriages, brutal wars against Scotland and France and the devastating collapse of England's economy. Terror stalked his court, as factions plotted in the

shadows behind the throne to snatch ascendancy in religion and political influence. In doing so they have left a distorted picture of the man and his career, which often takes for granted exactly how he became the king's leading minister. The purpose of this thesis is to describe how Cromwell rose so spectacularly, by examining previously neglected areas of work he undertook for the king, and presenting the first rounded study of Cromwell and his early career. A new study of Cromwell, which focuses on aspects of his life and work which have never before been examined, enables new insights to be drawn about the minister himself,

while shedding fresh light on debate surrounding Henrician Court and government. An examination of Cromwell's greatly neglected life as a lawyer and merchant in the 1520s demonstrates how he acquired many of the qualities which were required for him to prosper under Henry VIII, while fresh consideration of the manner of Cromwell's transition into the king's service challenges the longstanding belief about how and when this occurred. Despite the considerable evidence attesting to them in the State Papers, Cromwell's earliest responsibilities for the king - those concerning the Crown lands and King's Works, his management of the Church, and financing war with Scotland - have never before been examined. Doing so enables a new assessment of Cromwell's early career to be drawn, which challenges the prevailing belief that the break with Rome was vital in his becoming chief minister. Examination of Cromwell's earliest activities in government then presents an intriguing perspective on Cromwell as an administrative reformer. And the first comprehensive account of his role in the Anglo-papal schism not only offers new insights into his role and influence over this, but questions the existing accounts of the politics of the 1530s.
