Na primeira década do século XXI, o pensamento e a produção da fotografia foram alterados pela disseminação das câmeras digitais, da circulação das imagens via internet e dos softwares de pós-produção. Assim, a fotografia ganhou crescente espaço nas grandes mostras de arte pelo mundo e no mercado de arte. Nossa cultura antropofágica mostrou-se um processo potente para gerar uma fotografia vibrante que passou a ser pesquisada e divulgada por curadores e instituições do mundo inteiro. Este livro de referência apresenta 52 expoentes brasileiros neste cenário. Este ebook traz imagens que são melhor visualizadas em tablets. In the first decade of this century, thought and photography production have been changed by the popularization of digital cameras, images shared through internet and post-production software. Thus, photography increased its space in the big world of art exhibitions and market. Brazilian anthropophagic culture proved to be a powerful process to create a vibrant photography production that became object of research and propagation by curators and institutions worldwide. This reference book presents 52 brazilian exponents of this scenario. This ebook contains images that are best viewed on tablets.

At the Edge of Reformation springs from Peter Linehan's continuing interest in the history of Spain and Portugal, on this occasion in the first half of the fourteenth century between the recovery of each kingdom from widespread anarchy and civil war and the onset of the Black Death. Focussing on ecclesiastical aspects of the period in that region (Galicia in particular) and secular attitudes to the privatisation of the church, it raises inter alios the question why developments there did not lead to a permanent sundering of the relationship with Rome (or Avignon) two centuries ahead of that outcome elsewhere in the West. In addressing such issues, as well as of neglected archival material in Spanish and Portuguese archives, Linehan makes use of the also unpublished so-called 'secret' registers of the popes of the period. The issues this volume raises ought to be of interest not only to students of Spanish and Portuguese society but also to those interested in the developing relationship further afield of the components of the eternal quadrilateral (pope, king, episcopate, and secular nobility) in late medieval Europe as well as of the activity in that period of the secular-minded sapientes. In this context, attention is given to the hitherto neglected attempt of Afonso IV of Portugal to appropriate the privileges of the primatial church of his kingdom and to the glorification of his Castilian son-in-law as God's vice-gerent in his.

This is the untold story of how black saints - and the slaves who venerated them - transformed the early modern church. It speaks to race, the Atlantic slave trade, and global Christianity, and provides new ways of thinking about blackness, holiness, and cultural authority.

Like previous collections based on congresses of the European Society of Translation Studies (EST), this volume presents the latest insights and findings in an ever-changing, ever-challenging domain. The twenty-six papers, carefully chosen from about 140 presented at the 4th EST Congress, offer a bird's eye view of the most pressing concerns and most exciting vistas in Translation Studies today. The editors' final choices reflect a focus on quality of approach, originality of topic, and clarity of presentation, and aim at capturing the most salient developments in the contemporary theory, methodology and technology of TS. As always in EST, the themes covered relate to translation as well as interpreting. They include discussion of a broad range of text-types and skopoi, and a diversity of themes, such as translation universals, translation strategies, translation and ideology, perception of translated humor, translation tools, etc. Many of the papers force us to take a fresh look at seemingly well established paradigms and familiar notions, while also making recourse to work being done in other disciplines (Semiotics, Linguistics, Discourse Analysis, Contrastive Studies).

This volume focuses on the interdisciplinary investigation of Portuguese humanism, especially as a noteworthy player in the international network of early modern scholarship, literature and visual arts.

This fourth Variorum collection of articles by Peter Linehan comprises items largely from the past decade. The studies represent further investigation of themes broached in earlier works, in particular the latest report on the movements of Cardinal John of Abbeville, and the related subjects of historiography and historians, the interplay of history and government, and aspects of sacral monarchy. Articles on Zamora's frustrated legal history and Zamora's cardinal extend the Castilian theme across the territorial frontier into the kingdom of Portugal, and two other items explore English ramifications and developments in papal procedures.

Dois universos estéticos distantes, a fotografia e a poesia, são aqui conectados pela sensibilidade e erudição do poeta, crítico e curador Adolfo Montejo Navas, que mereceu pelo ensaio o prêmio Marc Ferrez de Fotografia em 2015, na categoria Reflexão Crítica. Com uma análise refinada, o autor vai traçando afinidades eletivas, alianças e reverberações, evidenciando diálogos, conceitos e referências poéticas entre esses dois universos. De um lado, encontramos a fotografia, linguagem que influenciou e influencia de maneira marcante a contemporaneidade; de outro, a poesia, em certo sentido uma "reliquia" em nossos tempos, mas que continua a inspirar a humanidade

desde a Antiguidade. Nessa cartografia fronteiriça a imagem se destaca como matriz comum, uma defesa expandida da poiesis como linguagem da criação inaugural. Ao percorrer a fotografia do século XX, o crítico trata das inescapáveis questões contemporâneas que essa linguagem traz, como seu permanente processo de transformação por sucessivas inovações técnicas, em especial a mais recente revolução digital. Falar da fotografia hoje é falar de um momento em que já não cabem classificações taxativas – esvai-se cada vez mais a distinção entre fotógrafos e artistas que utilizam a fotografia, por exemplo. Já a poesia é vista aqui não como sinônimo de poema, mas sim como uma forma particular de conhecimento. Parte do virtuoso trabalho do autor é alinhar uma pluralidade de referências e de olhares de modo a ampliar as percepções do leitor em relação às duas formas artísticas. No final, o livro traz um encarte impresso em 4 cores, com "24 poéticas": Montejo Navas apresenta perfis e obras de 24 artistas, que vão desde os artistas contemporâneos brasileiros Rodrigo Braga e Paulo Bruscky até nomes consagrados mundialmente como Robert Frank e Man Ray.

The volume "Revisiting Hormuz", gathers the proceedings of a Conference organized in March 2007 by the Calouste Gulbenkian Foundation, through its Centre Culturel Calouste Gulbenkian in Paris. The year 2007, exactly five centuries after the Portuguese first landed on the island of Hormuz, seemed to the scientific coordinators Rui Manuel Loureiro and Dejanirah Couto a very appropriate moment to bring together a large group of specialists that could establish the current state of the art in field of the history of Portuguese interactions with Hormuz and the Persian Gulf region. The chronological borders of the Conference, quite naturally, were extended to the early decades of the 17th century, to include the final departure of the Portuguese from Hormuz in 1622 and subsequent developments. Although the focus of the Paris Conference was supposed to be history, in any of its political, social, economic or cultural variants, the complex nature of Portuguese interactions with Hormuz and Safavid Persia, that spanned for more than a century, and also the existence of an important monumental heritage of Portuguese origin in the Gulf area, made the presence of art historians, architects, and archaeologists desirable.

National studies have demonstrated their inability to correctly understand global phenomena, and the way in which they affect societies. This chronologically ambitious book investigates methodological and theoretical issues from Roman times to the present, in terms of globalization. In this context, one of the most relevant parameters of change emerges: the itinerancy of culture and knowledge. Therefore, this volume argues that itinerant agents carry with them cultural baggage, transporting and transmitting it to other spaces. In this way, interconnection begins, producing active changes in global history and visual culture. Contributions to this book focus on comparative studies, the evolution of global phenomena, historical processes in their diachrony, regional studies, changing economies, cultural continuities, and methodological questions on globalization, among others. In addition, the book opens with a contribution from Professor Peter Burke.

Memory is a subject that recently has attracted many scholars and readers not only in the general historical sciences, but also in the special field of art history. However, in this book, in which more than 130 papers given at the XXIXth International Congress of the History of Art (Amsterdam) 1996 have been compiled, Memory is also juxtaposed to its counterpart, Oblivion, thus generating extra excitement in the

exchange of ideas. The papers are presented in eleven sections, each of which is devoted to a different aspect of memory and oblivion, ranging from purely material aspects of preservation, to social phenomena with regard to art collecting, from the memory of the art historian to workshop practices, from art in antiquity, to the newest media, from Buddhist iconography to the Berlin Wall. The book addresses readers in the field of history, history of art and psychology.
