

Worked Examples To Eurocode 2 Volume 2

This second edition of Precast Concrete Structures introduces the conceptual design ideas for the prefabrication of concrete structures and presents a number of worked examples that translate designs from BS 8110 to Eurocode EC2, before going into the detail of the design, manufacture, and construction of precast concrete multi-storey buildings. Detailed structural analysis of precast concrete and its use is provided and some details are presented of recent precast skeletal frames of up to forty storeys. The theory is supported by numerous worked examples to Eurocodes and European Product Standards for precast reinforced and prestressed concrete elements, composite construction, joints and connections and frame stability, together with extensive specifications for precast concrete structures. The book is extensively illustrated with over 500 photographs and line drawings. A concise and practical introduction to the new European Code of Practice for Design of Concrete Structures, EC2. This book guides the reader through the background to the Eurocodes and explains the main differences between them and the equivalent Standard Codes of Practice. This is followed by worked examples for the following structures: A multi-storey office building with three forms of floor construction A basement to the office building with three types of foundations A free-standing cantilever earth-retaining wall A large underground service reservoir An open-top rectangular tank on an elastic soil An open-top cylindrical tank on an elastic soil In addition to the design of all the elements, the analysis of each structure is fully explained. This applies particularly to the design of the basement, and the tanks bearing on elastic soils, for which specially derived tables are included in appendices to the book. The calculations are complemented by reinforcement drawings in accordance with the recommendations in the third edition (2006) of the Standard method of detailing structural concrete, with commentaries on the bar arrangements. This book can be used as a stand-alone publication, or as a more detailed companion to Reynolds's Reinforced Concrete Designer's Handbook, now in its 11th edition. The comprehensive treatment of the designs, and the variety of structures considered, make this a unique and invaluable work.

This book is the companion volume to Design Examples for High Strength Steel Reinforced Concrete Columns – A Eurocode 4 Approach. Guidance is much needed on the design of high strength steel reinforced concrete (SRC) columns beyond the remit of Eurocode 4. Equations for design resistances are presented clearly so that they can be easily programmed into design spreadsheets for ease of use.

All the authors have been researching and teaching the behaviour and design of prestressed concrete structures for over thirty-five years and the proposed new edition of the book reflects this wealth of experience. The work has also gained much from Professor Gilbert active and long-time involvement in the development of standards for concrete buildings and concrete bridges.

Decoding Eurocode 7 provides a detailed examination of Eurocode 7 Parts 1 and 2 and an overview of the associated European and International standards. This book presents new guidelines for the control of cracking in massive reinforced and prestressed concrete structures. Understanding this behavior during construction allows engineers to ensure properties such as durability, reliability, and water- and air-tightness throughout a structure's lifetime. Based on the findings of the French national CEOS.fr project, the authors extend existing engineering standards and codes to advance the measurement and prediction of cracking patterns. Various behaviors of concrete under load are explored within the chapters of the book. The authors propose new engineering rules for crack width and space assessment of cracking patterns, and provide recommendations for measurement devices and protocols. Intended as a reference for design and civil engineers working on construction projects, as well as to aid further work in the research community, applied examples are provided at the end of each chapter in the form of expanded measurement methods, calculations and commentary on models.

This textbook describes the rules for the design of steel and composite building structures according to Eurocodes, covering the structure as a whole, as well as the design of individual structural components and connections. In addition, the fabrication and erection procedures, as well as the related quality requirements and the quality control methods are extensively discussed (including the procedures for bolting, welding and surface protection). The book is supplemented by more than fifty numerical examples that explain in detail the appropriate procedures to deal with each particular problem in the design of steel structures in accordance with Eurocodes. The book is an ideal learning resource for students of structural engineering, as well as a valuable reference for practicing engineers who perform designs on basis of Eurocodes.

This book is focused on the theoretical and practical design of reinforced concrete beams, columns and frame structures. It is based on an analytical approach of designing normal reinforced concrete structural elements that are compatible with most international design rules, including for instance the European design rules – Eurocode 2 – for reinforced concrete structures. The book tries to distinguish between what belongs to the structural design philosophy of such structural elements (related to strength of materials arguments) and what belongs to the design rule aspects associated with specific characteristic data (for the material or loading parameters). A previous book, entitled Reinforced Concrete Beams, Columns and Frames – Mechanics and Design, deals with the fundamental aspects of the mechanics and design of reinforced concrete in general, both related to the Serviceability Limit State (SLS) and the Ultimate Limit State (ULS), whereas the current book deals with more advanced ULS aspects, along with instability and second-order analysis aspects. Some recent research results including the use of non-local mechanics are also presented. This book is aimed at Masters-level students, engineers, researchers and teachers in the field of reinforced concrete design.
