A survey conducted at the beginning of 2002 revealed that, despite the existence of laws to criminalise it, money laundering was a little-understood phenomenon in many parts of southern Africa. While it had been known for a long time that, in the words of a veteran Canadian undercover agent, "people commit crimes to make money so that they can get power and so that they can buy stuff?" (Mathers 2004), outside of the banking sector there was a low level of appreciation of the risks arising from the proceeds of crime. The obligations implicit in the recommendations of the Financial Action Task Force (FATF) did not significantly influence regulatory planning. The last four years have witnessed a dramatic shift in the way countries in the region deal with the proceeds of crime. In August 2006 Malawi adopted a bill against money laundering and the financing of terrorism, as a visible expression of commitment to confront these activities. Before Malawi acted, South Africa, Mauritius, Zambia, Botswana and Zimbabwe had each centred their strategies against money laundering on similarly titled legislation. This monograph contains analyses of the frameworks taking shape in most of these countries. Tracing their proximate inspiration from international instruments such as the United Nations Convention Against Transnational Organised Crime, the structure and content of the laws in southern Africa are heavily influenced by the recommendations of the FATF. It is somewhat inevitable that in the monograph their efficacy is assessed, firstly, against the backdrop of the recommendations, and thereafter against the peculiar challenges the laws have to confront.

Building a Better Bridge is a record of the fourth "Building Bridges" seminar held in Sarajevo in 2005 as part of an annual symposium on Muslim-Christian relations cosponsored by Georgetown University and the Archbishop of Canterbury. This volume presents the texts of the public lectures with regional presentations on issues of citizenship, religious believing and belonging, and the relationship between government and religion—both from the immediate situation in Bosnia-Herzegovina and from three contexts further afield: Britain, Malaysia, and West Africa. From February 24 -28, 1992 an international symposium on Durability of Disease Resistance was held at the International Agricultural Centre in Wageningen, the Netherlands. The symposium, organized by the Department of Plant Breeding of Wageningen Agricultural University and the Centre for Plant Breeding and Reproduction Research, CPRO-DLO, was part of the DGIS funded programme Durable Resistance in Developing Countries. Without any form of prevention or protection nearly all crops will be seriously or even severely damaged by a range of pathogens. In modern agriculture man has been able to control many if not most pathogens using i) pesticides, ii) phyto sanitary methods such as control of seed and plant material in order to start a crop disease free, iii) agronomic measures such as crop rotation, iv) disease resistance or combinations of these measures. Over the years the use of pesticides has increased enormously and so did the problems associated with pesticide use, such as environmental pollution and building of resistance and tolerance to these pesticides in the pathogens. The use of resistance too increased strongly over the years and here too problems arose.

Animation has had a global renaissance during the 1990s, and nowhere is this more evident than in Asia. With the exception of China and Japan, most Asian nations are relatively new to this art form. Over the last decade, countries such as Taiwan, South Korea, the Philippines, and Thailand, as well as China, have acted as major offshore production plants for North American and European studios. One of the spurs for this increase in activity has been the global growth of terrestrial, cable, satellite, and video systems, all demanding large menus of programming, including animation. A second spur has been the exceptional popularity that Japanese animé has enjoyed across Asia, Europe, and the United States. Despite these developments, there has not been corresponding growth of a serious literature covering industrial and aesthetic issues about Asian animation, and the small amount of work that has been produced has not been published in English. Animation in Asia and the Pacific also offers vignettes of the fascinating experiences of a group of animation pioneers. The historical and contemporary perspectives derive from interviews, textual analysis, archival research, and participation/observation data.

It is to show that a Pilgrim's Progress can come only from someone who believes and teaches ALL the counsel of God, without flinching, yea, with loving-kindness. Illegally, He sat in a jail cell over a river for 12 years with his Bible, Galatians by Luther, and another book or two. He had the choice of feeling miserable and murmuring, or of filling his time, thoughts, and energies with studying that Bible, and seeking a way to be of help to his more comfortable, but less dedicated, brothers and sisters. Listen, dear saints, you can't do any better than reading Bunyan. Like Gurnall, he covers everything here and there, and with a sweetness that can come only from God. What a shame that his large heart should be encased in such small print. But, like digging gold, it is worth the time and trouble to dig spiritual gold. Bunyan (1628-1688) rose from an humble beginning to being a preacher to a little house church, to 12 years in jail because he would not agree to quit preaching, to a huge church in London. He wrote 66 books, nearly all while in jail.
